**IN THE MATTER OF A DISCIPLINARY HEARING
PURSUANT TO SECTIONS 20 AND 24 OF BY-LAW NO. 1 OF
THE MUTUAL FUND DEALERS ASSOCIATION OF CANADA**

Re: ASL Direct Inc. and Adrian Samuel Leemhuis

ORDER

WHEREAS on October 17, 2008, the Mutual Fund Dealers Association of Canada (the “MFDA”) issued a Notice of Hearing pursuant to sections 20 and 24 of MFDA By-law No. 1 in respect of a disciplinary proceeding commenced against ASL Direct Inc. and Adrian Samuel Leemhuis (the “Respondents”);

AND WHEREAS on December 4, 2008, the first appearance in this proceeding took place before a Hearing Panel of the Central Regional Council of the MFDA (the “Hearing Panel”) and a schedule was set for the continuation of the proceeding;

AND WHEREAS at the first appearance, the Hearing Panel ordered that a motion to be brought by the Respondent Adrian Samuel Leemhuis (the “Leemhuis Motion”) would be heard on Tuesday, March 3, 2009;

AND WHEREAS on January 14, 2009, with the consent of counsel for Staff of the MFDA (“Staff”) and counsel for the Respondent Adrian Samuel Leemhuis, the date for the Leemhuis Motion was postponed to be heard on April 7, 2009;

AND WHEREAS at the first appearance, Staff was ordered to provide the Respondent Adrian Samuel Leemhuis with disclosure in accordance with Rule 10 of the MFDA Rules of Procedure on or before Monday, March 30, 2009;

AND WHEREAS Staff and counsel for the Respondent Adrian Samuel Leemhuis consent to the postponement of the hearing of the Leemhuis Motion until Tuesday, May 5, 2009 and the postponement of Staff's disclosure deadline to Friday, May 1, 2009;

IT IS HEREBY ORDERED THAT:

1. On Tuesday, April 7, 2009 at 9:00 a.m., (Eastern) an appearance will be held by conference call to revise the schedule for the continuation of this proceeding and address any procedural matters that the parties wish to raise at that time;
2. The Leemhuis Motion shall be heard by the Hearing Panel on Tuesday, May 5, 2009 at 10:00 a.m. (Eastern); and
3. Staff shall provide the Respondent Adrian Samuel Leemhuis with disclosure in accordance with Rule 10 of the MFDA Rules of Procedure on or before Friday, May 1, 2009.
