### **MFDA sets date for Ronald L. Brown Hearing in Toronto**

**February 23, 2010** (Toronto, Ontario) – The Mutual Fund Dealers Association of Canada (“MFDA”) commenced a disciplinary proceeding in respect of Ronald Lindsay Brown by Notice of Hearing dated May 14, 2008.

As previously announced, an appearance by teleconference took place in this proceeding today before a Hearing Panel of the MFDA’s Central Regional Council.

The hearing of this matter on its merits has been scheduled to take place on June 22, 2010, commencing at 10:00 a.m. (Eastern), or as soon thereafter as the hearing can be held, in the Hearing Room at the offices of the MFDA located at 121 King Street West, Suite 1000, Toronto, Ontario.

The hearing will be open to the public, except as may be required for the protection of confidential matters.
